- 2. Consistent unsatisfactory progress/results in examinations of the school.

- 4. Non-payment of school dues within the specified time.
- 5. Conduct & behavior of my son/daughter is harmful to other students, teaching and non-teaching staff of the school.
- 6. Misbehaviour of parents/guardians of any student in and around the school premises causing inconvenience to the teaching or non teaching staff of the school as well as to management authorities of the school.
- 7. Stealing or extortion of money or items or goods from other students, teaching and non-teaching staff of the school at any point of time.
- 8. Damaging or destroying school property in any manner whatsoever at any point of time by a student or his parent or guardian.
- 9. Any word or utterance or deed of the student likely to tarnish the image and reputation of the school in any manner whatsoever.
- 10. Gross insubordination and grave misconduct causing harm to the reputation of school.
