- ii) If he / she becomes of unsound mind.
- iii) If he / she is adjudged insolvent or if he / she applies to be so adjudged.
- iv) If he / she has been convicted of any offence for not less than 6 months and,
- v) If he / she is absent from India without permission of other Trustees (which permission if granted will not be withdrawn) for a continuous period of more than 6 months.

6. Administration of the foundation :

- i) All the Trustees together be called as the Board of Trustees, headed by the Chairman / Chair person to be elected once in every 5 years from amongst the Trustees. In case of any vacancy to the post of the Chairman / Chair person, the person succeeding him shall hold office for 5 years and may be re-appointed. Sri Naresh Chandra Das shall be the 1st Chair person of the Foundation and hold the post as Managing Trustee / Chairman / Chair person for his life time. The trustees shall hold office for life from the date of appointment of nomination as a Trustee. Any question arising in the administration of the Foundation shall be decided by the remaining Trustees by vote of the majority of the Trustees as are present at a duly convened meeting, and the Chairman / Chair person of the meeting shall have a casting vote in case of equal votes. The Chairman / Chair person may also take administrative decision, which are to be ratified in the subsequent meeting. The Trustees will be honorary and will not be entitled to any remuneration. The trustees may also take decision by circulation of the Foundation matters approved by majority of the Trustees, after the matter to be so decided have been circulated to all the Trustees.
- ii) The Trustees shall elect from amongst themselves, a Managing Trustee and a Treasurer and they shall hold office for a period of 5 years. The settler will be the first ex-officio Managing Trustee for his life time. He shall hold office so long as he desires. The Managing Trustee may appoint one of the Trustees as Treasurer in consultation with other Trustees in a meeting, if felt necessary; otherwise, the post of the Treasurer may be filled up by the Trustees by majority votes. The trustee shall take charge of the assets of the Foundation and hold and administer the same in accordance with the terms of this Deed of Trust. The managing trustee is empowered to appoint any person (s) as he felt necessary for benefit of the institution (s) created by

The office of the Trustee falling vacant either by death or by resignation or removal may be filled up by the Board of Trustees or by the Chairman / Chair person of the Foundation as herein before contained.

7. **Funds and properties of the Foundation :** The funds and properties of the Foundation shall consist of -

- The sum of Rs. 10,000.00 (Rupees Ten thousand) only as has been settled by the Settler and to be put in the Bank Account of the foundation with any Nationalised Bank.
- Gifts / donations either in cash or in kind which may be made by any Philanthropic Institutions / person or members of the public who are in sympathy with the aims and objects set out herein including any donations made for any such specified purpose or object. Foreign donations may be accepted strictly in accordance with the provisions of the concerned Rules and law without any compromise with the aims and objects of the Foundation.
- Property movable and/or immovable which may be acquired by the Foundation by purchase, exchange, lease, gift or otherwise.
- Income and profits from the properties of the Foundation.
- Any fees, charges, etc. as may be collected in course of any public or private performance etc.

8. **Objects of the Foundation :** The objects of the Foundation will be as under :

- To impart education in any stream - general, technical, medical, para-medical and any other.
- To set-up schools, colleges, universities of national and international standard with such provisions as the Trustees may decide and to set up any other institution or industry for allied services and promotion of vocational activities of the students.
- To provide assistance to poor and deserving students in any shape as the Trustees may decide for furtherance of education.
- For the purposes of Health Education

ation in setting up the various facilities such as Blood Bank, Operation Theatre, Eye-Bank, Burn Centres, Heart Centres etc. for the poor patients.

ii) To make provisions of outdoor dispensary or assistance thereof and also to run Mobile Medical services for the poor patients.

iii) To set up hospitals primary as well as Super Speciality / nursing homes Health Care Units for the poor patients for children / women and for imparting better medical cure of the citizens.

iv) To render assistance to the handicapped - both physical and mental.

v) To contribute to other social welfare organizations providing medical assistance viz. Red Cross, CRY etc.

e) To provide monetary assistance / aid for General Education, Technical Education and Health Education including incidental Medical treatment to the poor and needy persons as may be decided by the Trustees or Managing Trustee.

9. **Impossibility of objects of the Foundation :** If the objects of the Foundation become impossible of fulfillment, it shall be open to the Managing Trustee to alter the terms of the Foundation and thereupon a new Foundation embodying the altered objects shall come into being and such new Foundation shall be subject to all the conditions of this Deed. The Foundation property shall become the property of such new Foundation and to be governed by the Trustees thereof.

10. **Powers of the Trustee :**

i) The Trustees shall be competent and are hereby empowered to :

a) Receive any more and further assets in any shape or form as and when given by the Settler of the Foundation, any of the Trustees or any other persons or institutions or industries national & international for promotion of Foundation objectives.

b) Receive and accept funds by collecting donations, subscriptions, grants, presents, assistance, aids, contributions or loans from the Government of India, any State Government, Corporation, Bank, Chamber of Commerce, any other Public or Private Bodies, Members of the Public, Limited Companies, Firms, Associations, Charitable Bodies and any other organisations including contributions or loans from Non-Residential Indians, Foreigners, Foreign Countries, Bodies, Institutions, Individuals.

- d) Acquire on lease, or otherwise, sell, mortgage, lease out or transfer in any other manner properties (movable or immovable), construct buildings and effect other improvements for the purpose of the foundation.
- e) Help and render relief to the poor in all possible manner as the Trustees may decide.
- f) Make donations or contributions for attaining and in furtherance of the objects of the foundation.
- g) Borrow for the purpose of the Foundation on personal credit of the Trustees with or without charges or responsibility upon the assets of the foundation.
- h) Meet necessary expenses to be incurred in connection with the execution and administration of foundation.
- i) To set up institution / welfare based centres / industries on behalf of the foundation, Controlled / independent and to frame a schemes of management in respect of all the units / institution with the settler of the foundation as settler.
- j) Establish centres in different parts of the country for carrying out the objects of the foundation.
- k) Do all or any of the aforesaid things, transactions or matters and do all such other things as are incidental or conducive to the attainment of the aims and objects of the foundation.
- l) The trustee herein may admit new trustee within the admissible limits with the consent of the Managing Trustee or the Managing Trustee may make any such appointment and / or co-opt as and when necessary to serve the interest of the Foundation better.
- m) A trustee may vacate his office with the consent of the remaining Trustees of the Trust be serving three month's notice to the other existing Trustees of the Trust or a Trustee shall be removed from the Trust provided he is declared insolvent or insane or punished under the criminal law.

III) All or any of the powers vested in or exercisable by the Trustees as per this Deed of Foundation shall be capable of being performed or exercised by Trustees (at least two members) present at the meeting of the Trustees and any action or decision of such Trustees shall be valid and effective as it would have been if done by all the Trustees.

IV) The Trustees, if they so choose and for the benefit of the Foundation may delegate by means of a resolution in writing any or all of their powers to any one or more of them or any other person for such time and purpose as them deem fit.

11. **Reimbursement of expenses and remuneration :** The trustees shall be entitled to receive and be paid out the Foundation Fund, all out of pocket including traveling and other expenses reasonably and legitimately incurred by them in connection with foundation matters and incurred for attending any meetings of the Trustees or any committee thereof. Save as aforesaid the trustees including the Managing trustee shall not be entitled to any remuneration for serving as such; provided that the Trustees may employ any of the Trustees being engaged in any profession or business, or in a firm of which he shall be a member, to do any act or transact any business (whether or not an act or business which only a persons engaged in that profession or business can do) and may pay such charges for the act or business done by him or his firm as aforesaid as he or they might make or recover if the Trustee or whose firm may be so employed was not a Trustee.

12. **Meeting of the Trustee :**

I) The meeting of the Trustees shall be presided over by the Chairman/Chairperson of the foundation and in his/her absence the Managing Trustee and in his absence, the Trustees present in the meeting shall elect one of them to preside over the meeting.

II) The Trustees shall meet from time to time as and when necessary to transact business and for considering the betterment of the foundation and its assets. The Chairman/Chairperson of the Foundation or the Chairman of the meeting, as the

which have not been spent in any year shall be invested in the modes prescribed under the provisions of the Indian Trusts Act 1882 and not violative of the provisions of the Income Tax Act in force.

19. **Acquisition and Sale of the foundation properties :** The Trustees shall at their discretion, acquire, purchase or sell immovable properties or moveable properties in the course of managing the foundation. However, any sale of immovable property shall require prior consent of at least 3/4th majority of the Trustees.
20. **Dissolution of the Foundation :** In the event of dissolution or winding up of the foundation, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees / members of the Board, but same shall be transferred to another charitable foundation, society, whose objects are similar to those of this Foundation and which enjoys recognition under relevant section of the Income Tax Act 1961.
21. **Income of foundation not be be applied for the personal benefit of Trustee :** No income of the foundation shall be applied for the personal benefit either of the Trustees or of the settler.
22. **Amendment of Terms of the Deed of Foundation :** No amendment in the terms of this Deed shall be made without obtaining the prior written permission of the Commissioner of Income Tax.
23. **Achievement of objects of foundation :** The objects of the foundation shall be achieved without involving any activity for profit.
24. **Foundation irrevocable :** The foundation formed is irrevocable.
25. **Funds / income of foundation to be utilized for objects of the foundation :** The funds / Income of the foundation shall be solely utilized for achieving the objects of the foundation and no portion of it shall be utilized for the benefit of the Trustees by way of interest, bonus, dividend, profit etc.
26. **Benefits of foundation open to all Indians :** The benefit of the foundation shall be open to all Indians irrespective of caste, creed or religion.
27. **Maintenance of Accounts :** The Trustees shall maintain proper and regular accounts and such books of accounts shall be kept at the office premises. Each
